that (a) the Debtor would not use signwalkers on or near subject location; and (b) NorthPark could place a barricade on the front door of the store, after the conclusion of the store closing sales, provided however, that until the Debtor turns over possession of the store, it will continue to have access to the store through an alternate entrance. With these agreements, the Limited Objection has been resolved.


