24 **PLEASE TAKE NOTICE** that the "Debtor's Motion for Order (1) Extending
25 Time to Assume or Reject Unexpired Leases of Nonresidential Real Property, (2)
26 Approving a Procedure for the Rejection of Such Leases, and (3) Granting Other Related
27 Relief" (the "Motion"), filed on May 30, 2008, is set for hearing on June 24, 2008, at 2:00
28 p.m., in Courtroom 1575, United States Bankruptcy Court, 255 East Temple Street, Los

1 Street, Los Angeles, California. Any objection to the Motion must be filed and served no
2 later than 14 days prior to the hearing. Failure to timely file and serve an objection may
3 be deemed by the Court to be consent to the granting of the relief requested in the
4 Motion.


5 Since the commencement of this chapter 11 case on March 19, 2008, the
6 Court has approved the Debtor's rejection of 8 nonresidential real property leases under
7 which the Debtor is the lessee. As of this time, the Debtor is the Lessee under 16 leases
8 of nonresidential real property (identified in the Motion) which have not been rejected (15
9 leases for retail stores operated by the Debtor, and a lease for the Debtor's corporate
10 headquarters). The Debtor is in the process of evaluating its opportunities for
11 reorganization, sale, and/or liquidation of its business and/or assets in their entirety or in
12 part. It would be premature and detrimental to the estate to force the Debtor to determine
13 whether to assume or reject all of its remaining nonresidential real property leases (not
14 yet rejected) prior to determining whether there will be a sale of the Debtor's business
15 and/or assets, a restructuring, and/or a liquidation of some or all of the Debtor's
16 remaining assets. Therefore, in order to preserve and protect the interests of the estate,
17 creditors, and the Debtor, pursuant to the Motion, the Debtor requests a 90-day extension
18 of time for the Debtor to assume or reject nonresidential real property leases is necessary
19 and appropriate. Further, in the Motion, the Debtor requests approval of the procedure
20 set forth in the Motion for the rejection of leases. The Debtor believes that is fair,
21 appropriate, and in the best interests of the estate, creditors, and the Debtor.

22 In the Motion, the Debtor requests that the Court approve a procedure
23 where the Debtor can serve notice of the rejection, if any, of further leases of
24 nonresidential real property under which the Debtor is the lessee and if no objection to
25 any such rejection is received within 7 days following the date of service of the rejection
26 notice, the rejection will become effective 7 days following the date of such service.
27 Pursuant to the proposed procedure, if an objection is filed within the 7-day notice period,
28

1 the Debtor shall promptly schedule a hearing for consideration of the objection. See the
2 Motion for greater detail regarding the proposed procedure.


