eStyle, Inc. (the "Debtor"), debtor in possession, commenced the above-captioned reorganization case by filing a voluntary chapter 11 petition on March 19, 2008. The Debtor's emergency motion (the "Motion") with regard to utility companies and adequate assurance of payment pursuant to Bankruptcy Code § 366 was filed on March 19, 2008, and came on for hearing before the Court on March 21, 2008. At the hearing, the Court ruled that the Debtor shall provide adequate assurance of payment as proposed in the Motion and shall transmit such payment with notice that any utility provider (including entities the Debtor identifies in the Motion as entities the Debtor does not believe qualify as utility providers under Bankruptcy Code section 366) may object to the proposed adequate assurance, if any, by serving a written objection on bankruptcy counsel for the Debtor (at the address appearing in the upper left corner of the first page of this Notice) and filing the objection with the Court no later than April 4, 2008. Any response of the Debtor to any objection must be filed with the Court and served no later than April 9, 2008. To the extent that any objection is filed, a hearing on the objection will be held on April 16, 2008, at 10:00 a.m., in Courtroom 1575, United States Bankruptcy Court, 255 East Temple Street, Los Angeles, California.


If a utility provider has no objection to the proposed adequate assurance, the utility provider need not file any papers with the Court and there is no need to attend the hearing set for April 16, 2008, at 10:00 a.m. In the event that a party desires to request an emergency hearing, the Court has indicated that such a hearing may be available on April 1, 2008, subject to the Court authorizing such a hearing. Failure of any utility provider to file a timely objection as set forth above, may be deemed by the Court


