1           The resolutions of the various disputes saves the Estate nearly \$120,000 in  
2 purported cure obligations. The majority of the difference between the Debtor's proposed  
3 cure in its "Cure Schedule" and the Cure Objections was owing to the Landlords'  
4 requests for attorneys' fees as part of their cure. The negotiated resolutions significantly  
5 reduced the requested attorneys fees to less than half (cumulatively) of what was  
6 requested. In the case of the Maxtana, LLC objection, the Debtor was able to  
7 demonstrate to Maxtana that a majority of the amounts it claims were unpaid, had in fact  
8 been paid or were not owed. The Debtor submits that the resolutions are a result of an  
9 appropriate exercise of the Debtor's business judgment, and should be approved.


