22 captioned case (the "Debtor") for Order Fixing Deadline (Bar Date) for Filing Proofs of
23 Unsecured Claims and Claims under Section 503(b)(9), there being no timely-filed
24 objection or request for a hearing, and good cause appearing therefore, it is hereby
25 **ORDERED** as follows:

26 1. The deadline for (the "Bar Date") by which parties may file a proof of claim
27 or proof of interest in this case is October 20, 2008, except for (1) claims arising from
28 rejection of executory contracts or unexpired leases, (2) claims of governmental units,

1 and (3) claims arising as a result of transfer avoidance pursuant to chapter 5 of the
2 Bankruptcy Code.

3 2. The Bar Date by which creditors may file a proof of claim with respect to
4 claims arising from rejection of executory contracts or unexpired leases pursuant to 11
5 U.S.C. § 365 shall be (a) 30 days after the date of entry of the order authorizing the
6 rejection, or (b) October 20, 2008, whichever is later.

7 3. The Bar Date by which creditors may file a proof of claim with respect to
8 claims of "governmental units," as that term is defined in 11 U.S.C. § 101 (27), shall be
9 (a) 180 days after the date of the Order for Relief in this case, or (b) October 20, 2008,
10 whichever is later.

11 4. The Bar Date by which creditors may file a proof of claim with respect to
12 claims arising from the avoidance of a transfer under chapter 5 of the Bankruptcy Code
13 shall be (a) 30 days after the entry of judgment avoiding the transfer, or (b) October 20,
14 2008, whichever is later.

15 5. The Bar Date by which creditors may file a request for payment of Section
16 503(b)(9) Administrative Claim be October 20, 2008.

17 6. Any creditor or interest holder of the Debtor who fails to timely file and serve
18 a proof of claim or interest in accordance with this order shall be forever barred from
19 participating in the above-captioned chapter 11 case in any regard, including with respect
20 to voting on any proposed chapter 11 plan and distribution under a plan, and that the
21 holder of any such claim or interest shall be bound by the terms of any plan of
22 reorganization confirmed by the Court in the above-captioned case.
