1 On June 18, 2008, eStyle, Inc. (the "Debtor"), the debtor and debtor in possession
2 in the above-captioned case, filed a *Motion for Order Authorizing and Approving: (1) the*
3 *Sale of the Assets of Estyle, Inc. Free and Clear of Liens, and (2) the Assumption and*
4 *Assignment of Unexpired Nonresidential Real Property Leases and Executory Contracts*
5 *in Connection Therewith* ("Sale Approval Motion"). In connection therewith, on June 26,
6 2008, the Debtor filed a *Schedule of Proposed Cure Amounts Regarding (1) Unexpired*
7 *Real Property Leases and (2) Executory Contract, Which May be Assumed and Assigned*
8 *Pursuant to the Debtor's Motion for Order Authorizing and Approving (1) the Sale of*
9 *eStyle, Inc.'s Assets Free and Clear of Liens; and (2) the Assumption and Assignment of*
10 *Executory Contracts and Unexpired Nonresidential Real Property Leases* (the "Cure
11 Schedule"), which states the amounts the Debtor believed was necessary to cure
12 defaults under certain executory contracts and unexpired leases, some of which were to
13 be assumed and assigned to the buyer of the Debtor's assets. Objections to the Cure
14 Schedule were filed or made by certain parties, including Maxtana Avenue, LLC,
15 Taubman Cherry Creek Shopping Center, L.L.C., Bellevue Square Managers, Inc., the
16 Macerich Company, RREEF Management Company, and Westfield, LLC (collectively,
17 the "Objecting Landlords").

18 On July 16, 2008, the Court entered an order that granted the Sale Approval
19 Motion. With regard to the Objections to the Cure Schedule, however, the Court
20 continued the hearing to August 12, 2008, and subsequently, to August 26, 2008, at
21 11:00 a.m.

22 Prior to the continued hearing, the Debtor and each of the Objecting Landlords
23 resolved the objections to the Cure Schedule, as specifically set forth in a *Notice of*
24 *Resolution of Objections to Debtor's Proposed Cure Schedule in Connection with Sale of*
25 *Assets and Assumption and Assignment of Leases and Executory Contracts* ("Notice of
26 Resolution of Objections") filed by the Debtor on August 15, 2008.

27 The continued hearing on the Sale Approval Motion with respect to the objections
28 to the Cure Schedule took place in the above-captioned Court on August 26, 2008, the

8 resolutions set forth in the Notice of Resolution of Objections are hereby approved.
