1 On August 14, 2008, Baer & Troff LLP (“B&T”) a professional corporation,
2 filed its “First Interim Application for Approval of Compensation and Reimbursement of
3 Expenses by Special Corporate Counsel Baer & Troff for Debtor in Possession” (the
4 “Interim Application”). There were no objections filed with respect to the Interim
5 Application. The Interim Application came on for hearing before this Court on
6 September 9, 2008. The Court has considered the Interim Application and the facts and
7 circumstances of this case.

8 Pursuant to the Interim Application, B&T requested the Court’s interim
9 approval of fees incurred for services rendered following the commencement of the
10 Debtor’s chapter 11 case on March 19, 2008, through July 31, 2008, in the sum of
11 \$121,720.50, and approval of costs incurred during the same period in the amount of
12 \$377.42, for a total requested for interim approval in the sum of \$122,097.92. B&T has
13 requested that the Court authorize payment of this sum less the unused balance of B&T’s
14 prepetition retainer as of the commencement of this case (\$91,832.50), for total
15 requested for interim payment to B&T for services rendered and costs incurred through
16 July 31, 2008, in the sum of \$30,265.42.

17 Interim compensation of B&T, as set forth and approved below, is
18 reasonable compensation for actual and necessary services rendered by B&T and the
19 expense reimbursement approved below constitutes reimbursement for actual, necessary
20 expenses incurred by B&T, and good cause appearing therefor,

21 **IT IS ORDERED:**

22 1. The Interim Application is granted as requested, and interim
23 compensation for B&T for the period following the commencement of the Debtor’s case
24 on March 19, 2008, through July 31, 2008, with regard to fees requested for services
25 rendered and expense reimbursement for costs incurred, is hereby approved, as set forth
26 below.

27 2. Interim fees of B&T in the sum of \$122,097.92 are approved and
28 payment of such amount is hereby authorized, subject to paragraph 4 below.

1 3. Reimbursement of costs incurred by B&T in the sum of \$377.42 is
2 approved and payment of such amount is hereby authorized, subject to paragraph 4
3 below.

4 4. From the total amount authorized to be paid to B&T at this time
5 pursuant to paragraphs 2 and 3 above, the amount of the unused balance of B&T's
6 prepetition retainer as of the commencement of this case (\$91,832.50) is to be
7 subtracted.
