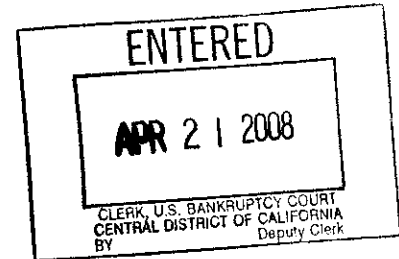
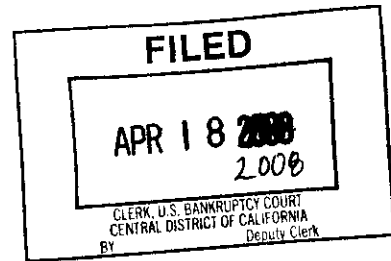

10 **IT IS HEREBY ORDERED** as follows:


- 11 1. The relief granted in the Interim Order is hereby granted on a final


